Jasmin Pani, the first student coordinator of ConXerv shares her enriching experiences with us:

What was your vision behind launching this committee?

When the course started in 2015, as the 1st batch, we faced a lot of questions, such as what sustainability is, what's our course curriculum, how it's different from other branches, and what will be our future etc. So, for us, it was not a committee, rather an identity, a forum to represent us, our batch and our branch. The aim was to create awareness about sustainability both inside and outside campus and to change the way in which sustainability was perceived.

The leaders of the bloc's member states met on Thursday for secret deliberations in an attempt to reach a consensus on who should fill the EU's top jobs.

Daily Court Digest: Major environment orders (June 4, 2019)

- Assess recharging of Delhi's groundwater: NGT: On May 31, 2019, the National Green
 Tribunal (NGT) directed the constitution of a Joint Committee of the Central Pollution
 Control Board, the Delhi Pollution Control Committee and the Central Ground Water
 Board to take samples of groundwater from across Delhi and study the methodology
 used in recharging it.
- 2. Use of plastic for packaging to be examined by a joint committee: On May 31, 2019, a petition calling for restrictions on the use of plastic bottles and multi-layered plastic packages used for packaging of carbonated soft drinks, liquor as well as other items, in view of the adverse impact on the environment and human health, came up for hearing before the NGT.
- 3. 'Polluter pays' principle needs to be applied once pollution is caused: NGT: The tribunal said that "once pollution is being caused, 'Precautionary', 'Sustainable Development' and 'Polluter Pays' principles have to be applied" and directed such actions to be taken in accordance with law and a further report submitted in a month.

Rambabu Dr. Paravastu, CEO, RSM-GC, holds 35 years of experience in consulting, research and teaching governance, sustainability and climate change. He has advised ITC, various companies of Tata Sons and a number of multinational companies in preparing Sustainability reports and Sustainability performance improvement. In a telephonic interview conducted on 1st July,2019, Mr Ram Babu shares his valuable insights with us:

In your view, how is sustainability influencing the overall strategy adopted by organizations at present?

In my view, no organization's overall strategy is completely influenced by sustainability. At present, there are certain critical trends and risks in the operating climate of businesses that need to be addressed. Organizations are taking care of these trends and addressing them appropriately. However, no organization's overall strategy is comprehensively shaped and driven by sustainability.

What is your view on government policies aligning with sustainable development?

Governments do play an integral role in the pursuit of sustainable development. They broadly articulate the vision which can play a guiding role for organizations. Through their acts and policies, government can put the spotlight on pressing environmental issues such as water scarcity. However, very often there are visible gaps between policy setting and policy implementation. Thus, we need adequate regulatory mechanisms to address these gaps and ensure effective implementation of government policies in practice.

How do you think consultancies are shaping up the future trajectory of Sustainability?

I strongly believe that consultancies are purely driven by commerce. They do address the immediate requirements however there is a lack of thought leadership in consultancies. Very often, consultancies do little with regards to advocacy. It's mainly NGOs and think tanks who actively engage in advocacy and demonstrate thought leadership.

Britain is obtaining more power from 0-carbon sources than fossil fuels (June 21,2019)

The milestone has been passed for the first five months of 2019. National Grid says clean energy has nudged ahead with 48% of generation, against 47% for coal and gas. The transformation reflects the precipitous decline of coal energy, and a boom from wind and solar.

54K mangroves to be razed in Maharashtra for Ahmedabad bullet train project (25th June 2019)

At least 54,000 mangroves spread across 13.36 hectares (ha) in Maharashtra will be razed for the Mumbai-Ahmedabad bullet train project, the state government confirmed on Monday. The floodwater will not enter Navi Mumbai, as no mangroves are being cut in the area. The government is in talks with locals who will be affected by the project and will give them appropriate compensation.

UNSC non-permanent seat: India's candidature receives unanimous endorsement (27th June 2019)
